## A Message for the Next President

As we rapidly approach November 4<sup>th</sup>, I ponder what the new President will do to sort out all these issues concerning us. *The National Voter* this month did what I think to be an excellent job in their "Letter to the New President". My article will be a summation of the National League's ideas for solutions in four main areas: climate change, healthcare, immigration, and the growing inequity between the socioeconomic strata.

In the area of **climate change** we have experienced severe heat, worsening hurricanes, and summer ice caps melting. 1998-2007 was the hottest decade ever and 2007 was the hottest year since record-keeping began. We know that the primary cause of this change is human activity in the form of GHG's, greenhouse gases. Those gases are created by carbon dioxide, which increases the greenhouse effect by trapping the heat in, deforestation, agricultural breakdown of dung emitting increased levels of methane and nitrous oxide, and industrial processing, e.g. coal and oil burning emissions. These GHGs affect health and safety especially in elderly and the poor, who can't cope with extremes. Secondly, the increased heat incubates germs and causes increasing infections. We already have antibiotic-resistant organisms; now more will develop due to the increase in heat on the planet. Security-wise, we will see mass movements of refugees from the extremes of weather and increasing conflicts over water. Money-wise, we will see increases in emergency room visits, where primarily the elderly and the poor go for healthcare. You and I will bear that burden. We will see food and crop losses and increased need for aid in storm and hurricane cleanup. LWV's action plan for climate change solutions includes a decrease in emissions by 20% by 2020, coupled with support of an International Kyoto type agreement. We also need to see federal support for state climate-control regulations. We could use the proceeds from emission allowances to develop new technology, e.g. American cars with emission standards like the Japanese cars.

**Healthcare** is the next solution focused issue on which LWV has input for our next President. We have 47 million without healthcare coverage. Basic healthcare should include plans that cover not only prevention of disease but also promotion of health, with emphasis on education, primary care, prenatal care and reproductive health, long term care and mental health. Currently, we spend one of every six dollars on healthcare. If we continue to spend at this rate without curbing the healthcare costs, by 2016 we will spend \$4.2 trillion per year. That is 20% of our GNP. Women and children are traditionally the worst served, and that continues. As an industrialized society, we are near the bottom of the list in our infant mortality rate, and our prenatal care record is also abysmal. Most can't afford regular doctor visits and rely on the emergency departments at hospitals for care when in crisis. If we could save the 75% of every healthcare dollar that we spend on chronic illness on prevention of those illnesses, think of the savings! By 2050 chronic diseases alone will cost us six trillion dollars, dollars that could be used more productively. We spend twice as much as other countries at our level of development that belong to the Organization for Economic Cooperation and Development, and they are typically healthier than we are. In the last eight years, medical coverage in the form of the Health Savings Account has helped primarily the wealthy who care pay high out-of-pocket deductibles for their care. Since 1997 the SCHIP, State Children's Health Insurance Program, has provided for six million low income children who are not eligible for Medicaid (called Medical in California.) The extension and expansion of this most helpful coverage, which now reduces the percentage of low income children without healthcare by one third, was vetoed by our current President and extended in its current form for only a short term by Congress.

We need nation-wide affordable accessible healthcare for all with cost containment; dollars need to go to care, not to insurance company coffers. This will reduce costs insured Americans now pay for the uninsured as well as their own costs, no matter how healthy they are. To reduce costs, we need to increase focus on prevention and expand insurance to the uninsured.

**Immigration** is the next item for our new President's ears. In 2006, there were 12 million unauthorized immigrants in the United States. Detaining and prosecuting of them would cost \$94 billion. Nearly four percent of the total population is in the country illegally. Of these, twenty-five to forty percent come in legally and outstay visas trying to keep the family units intact. So the current policies aren't working. Of the five million immigrant children, three million have parents who are illegal residents. Millions toil in the underground society with poor wages, dangerous and abusive working conditions, and they won't report crimes for fear of being identified and deported. LWV supports creation of a system for legal entry and a path to legal status, including citizenship for those who pay taxes, learn English, study civics, and meet other relevant criteria. We should strengthen enforcement by fining employers who hire illegal immigrants, and increase tracking of immigrants once they are in America. Immigration reform should support measures to improve the economies of the countries where the illegal immigrants come from, encouraging them to stay in their home countries. One and a half million immigrants bolster our economy by buying goods. Less than 3 percent of unauthorized immigrants are on food stamps and many pay social security and incomes taxes now. Legalizing many will increase taxes paid to both the states and the nation, and will boost our economy.

Lastly, dear new President, LWV would like to see you redefine our **tax system**. It is an unfair system where the wealthy get many shelters for their investments but the middle and lower classes struggle to live and pay taxes. Poverty is on the rise. In 2006, 36.5 million Americans were living in poverty, defined as an income of less than \$20,500 for a family of four. This is an increase from 31.6 million in 2001. The most affected are Hispanics at 21 percent, blacks at 24 percent and children at 17 percent. The gap is widening. Twenty percent of the earners at the top earned 51 percent of the Nation's total household incomes. This is fraying our social order! The first steps toward fairness should be to repeal the Bush tax break for the wealthy and to preserve the estate tax system for the largest inherited estates. Tax benefits for working families should be expanded, including the Earned Income Tax Credit, and adequate federal funding must be ensured to provide mandatory old age, survivors, disability and health insurance.

Over 100 students and members of the community attended. Patty Beyer, Amy Christensen-Wolfe and Ellen Dunbar presented the measures well and allowed time for questions and answers. MJC intern Sarah Jamieson and student League member Malorie Michaels assisted with set-up for the event and ensured that League materials were passed out to the audience.

Due to time limitations and the large number of propositions, our presenters covered the "hot topic" measures. Propositions that were covered were our local Measure S- Transportation Tax, Proposition 2 - Standards for Confining Farm Animals, Proposition 4 - Waiting Period and Parental Notification Before Termination of a Minor's Pregnancy, Proposition 5- Nonviolent Drug Offenses, Sentencing, Parole and Rehabilitation, Proposition 6- Police and Law Enforcement Funding, Criminal Penalties and Laws, Proposition 8 - Eliminates Right of Same-Sex Couples to Marry and Proposition 11- Redistricting.

Our Pros and Cons event has now become a tradition at MJC, and we are very fortunate to have this partnership with the Civic Engagement Project. We are also very fortunate to have Patty, Amy, and Ellen to make this event possible. Their time studying the measures and making the power point presentation made this event a huge success.
