President's Message

Dear Members

August 26th, Woman's Equality Day, marked the 90th anniversary of the constitutional amendment that granted women the right to vote. The nonpartisan League of Women Voters was founded in that same year. "Women's Equality Day is a celebration of such a basic part of our democratic process—the right to vote—and the opportunities to channel that power into real, lasting change, starting at the grassroots level," writes LWVUS President Elizabeth McNamara. As a League member, you have the opportunity to make a difference by helping voters become informed on the issues and the candidates.

Most people know our League for its work in conducting fair and impartial candidate forums. Now that we serve all of Stanislaus County, this involves more time and effort from our Voter Service Directors. Beginning this month, we will again be holding candidate forums in cities outside of Modesto and once again we will need your help. We are fortunate to have an excellent pair of Voter Service Directors, Ellen Dunbar and Marsha Waggoner; a cadre of trained and experienced League moderators; and cooperative City Clerks who help with facility arrangements and public access cable coverage. What we need is **your help**. If you can help at a forum, please contact voterservice@lwcstanislaus.org. The calendar of forums is listed on p. 4.

The League is also known for providing *Pros and Cons* of the ballot measures. These used to be provided in newspaper format but now will be available online at <http://www.cavotes.org> around September 3rd. Some people prefer to attend an oral pros and cons presentation so that they can ask questions. We will be holding a Pros and Cons discussion of the ballot measures at MJC on October 14th as part of the MJC community engagement project. Ellen Dunbar is putting together a team of League members willing to discuss the propositions in front of a large audience of students and interested voters.

Not as many people know our League for our advocacy work. Since we need to keep this completely separate from our voter education work, it is more difficult to get our message out. As I write this we will have just concluded a members' review of two local ballot issues in Modesto (see p. 4). We will also have discussed ways we can help **defeat Prop 27** which would eliminate the Citizens Redistricting Commission (see p. 3). Your work this election season carries on the spirit of the incredible group of women who founded the League of Women Voters ninety years ago when they finally got the right to vote. Thank you.

State and National

California's first Redistricting implementation is a major focus of the state League this year. The Voters FIRST Act authorized the creation of California's first 14 member Citizens Redistricting Commission to draw the lines for district boundaries for the state Assembly, Senate and Board of Equalization.

The current list of best qualified candidates for the commission includes Bev Finley from Stanislaus County. The list of applicants has been narrowed from 30,000 to 120. The final selection of 14 commissioners will be made by December 31, 2010. The commission will create the new district boundaries based on the 2010 census by September 15, 2011.

LWVC strongly opposes Proposition 27, which would eliminate the Citizen's Redistricting Committee, returning their responsibilities to the Legislature.

While the League wholeheartedly supports the redistricting reform process, we also oppose Proposition 20. Proposition 20 would add redistricting California's Congressional districts to the duties of the Citizens Redistricting Commission. This proposition would significantly add to the workload of the commission at this time. While we believe the Citizen's Redistricting Committee should draw the Congressional lines in the future, we believe the new process should be fully implemented first.

Nationally, the Disclose Act failed to get the 60 votes needed to avoid a filibuster, and climate change legislation also has stalled, but the League will continue to pressure the Senate to address these important issues after the recess.

During recess and the upcoming campaign and election season, do your best to discuss these issues with candidates and with the public. Special interest money spent on campaigns should be disclosed, and elected representatives must address climate change.

Positions on November Ballot Measures

The LWVC has taken stands on seven of the ten measures on the November ballot, is neutral on two, and has no position on one.

- **Oppose** Proposition 20, Redistricting of Congressional Districts
- **Oppose** Proposition 23, Suspends Clean Energy and Air Pollution Standards
- **Support** Proposition 24, Tax Fairness Act
- **Support** Proposition 25, Simple Majority Vote for Budget
- **Oppose** Proposition 26, Polluter Protection Act
- **Strongly oppose** Proposition 27, Eliminates State Commission on Redistricting
- **Neutral** on Proposition 21, \$18 Vehicle License Fee for State Parks and Wildlife Programs
- **Neutral** on Proposition 22, State Government Prohibited from Taking Local Funds
- **No applicable League position** on Proposition 19, Legalize and Regulate Marijuana

Fall Elections Forums Planning

League of Women Voters of Stanislaus County will be conducting election forums with candidates in three city races. Working with city staff, three forums are scheduled. Amy Wolfe will moderate a forum on Sept 21 in Oakdale for the Mayoral race and the City Council race. On September 22 Diane Bartlett will moderate the forum of City Council candidates in Riverbank. October 5 Julie Saugstad will conduct a forum in Turlock for the City Council race there.

Other forums are tentatively planned to be held at MJC for the Yosemite Community College District, State Senate District 12 and Assembly District 26.

Pros and Cons of Ballot Propositions Presented

The LWVSC with Modesto Junior College will present the Pros and Cons of the propositions on the ballot on October 14 in Forum 110, East Campus.

League to Assist Modesto City Council Committee

The League will moderate public forums on October 14th and October 21st for applicants seeking appointment to fill the District 5 seat held by outgoing councilwoman Kristen Olsen. Susan Novak will moderate and Marie Bairey will be the question sorter. Tentative plans are to hold the forums at Sylvan School. Final dates, place and time will be available on our website in October. The final filing date for applicants is September 23rd.

Advocacy Meeting Update

An advocacy meeting was held in the League office on August 19th for members to review local ballot propositions. Led by Local Action Director, Marie Bairey, there was a discussion of the three measures that will be on the ballot for Modesto City voters:

Measure J, a charter amendment to eliminate run-off elections for Council districts and to continue the run-off election for Mayor but hold it in February instead of December.

Measure K, a charter amendment that would clarify the language pertaining to run-off elections so that only valid votes for the office are the votes that count.

Measure L, an advisory vote to the City Council to provide sewer service to the unincorporated area known as the "Parklawn Neighborhood."

The consensus of the group was to recommend either a "support" or "neutral" position on Measures J and K pending further research on LWVC positions. It is hoped that a final recommendation can go to the Board at the September 8 meeting. The group decided to support Measure L with a stipulation that funding be secured before the City Council should take action.

Ann Krabach discussed LWVC opposition to PROP 27 and Prop 20. She suggested League members write letters to the editor of their local newspaper explaining why they are personally against PROP 27. These should not reference League membership because "only the President speaks for League."
